**CONDITIONAL NOTICE OF VACANCY
ASSOCIATE JUDGE, SIXTH JUDICIAL CIRCUIT**

Authorization pursuant to Illinois Supreme Court Rule 39 has been received by the Chief Judge of the Sixth Judicial Circuit to post a conditional notice of vacancy for associate judge. It is anticipated a vacancy in the office of Associate Judge will occur as a result of Associate Judge Jeffrey Geisler running unopposed in the general election on November 3, 2020 for the office of Circuit Judge of 6th Judicial Circuit, Illinois. Potential candidates are advised this vacancy is fully contingent upon certification by the Illinois Board of Elections of General Election Results declaring Judge Jeffrey Geisler the winner of said election. Applications are now being accepted for this vacancy which will be filled by vote of the circuit judges of the Sixth Judicial Circuit.

Pursuant to Supreme Court Rule 39, any attorney, who is a United States citizen, is licensed to practice law in Illinois, and is a resident of the Sixth Judicial Circuit may apply by electronically filing a signed application with the Director of the Administrative Office of the Illinois Courts on the form prescribed and furnished by the Director, The instructions for submitting an application electronically are available on the Supreme Court's website: <http://www.illinoiscourts.gov>.

PLEASE BE ADVISED THAT THE APPLICATION FOR APPOINTMENT TO THE OFFICE OF ASSOCIATE JUDGE WAS REVISED ON SEPTEMBER 17, 2019 AND ONLY APPLICATIONS ON THE REVISED FORM WILL BE ACCEPTED.

Whether electronically filed, mailed or hand delivered, all applications must be received in the Administrative Office within 30 days after the date of this Notice. **If filed electronically, the deadline is 11:59 p.m. on Wednesday, November 4, 2020. If mailed or hand delivered, the deadline is 5:00 p.m. on Wednesday, November 4, 2020.** A form for application may be obtained from either the Chief Judge's Office, the Administrative Office of the Illinois Courts or from the Illinois Supreme Court website: www.illinoiscourts.gov and download from the documents/application/forms link. **Applications will not be accepted if submitted via facsimile.**

Applicants for this position may also be required to make themselves available for an interview with the Circuit Judges of the Sixth Judicial Circuit. If an interview is necessary, the applicants will be notified of the date, time and place of their interview at the close of the application period.
