M.R.029650 - In re: Narles William Coleman. Disciplinary Commission.

Petition by the Administrator of the Attorney Registration and Disciplinary Commission to impose reciprocal discipline pursuant to Supreme Court Rule 763. Allowed. Respondent Narles William Coleman, who has been disciplined in the State of Indiana, is suspended from the practice of law in the State of Illinois for two (2) years and until he is reinstated in the State of Indiana.

Suspension effective April 9, 2019.

M.R.029652 - In re: Adam J. Wiensch. Disciplinary Commission.

Petition by the Administrator of the Attorney Registration and Disciplinary Commission to impose reciprocal discipline pursuant to Supreme Court Rule 763. Allowed. Respondent Adam J. Wiensch, who has been disciplined in the State of Wisconsin, is suspended from the practice of law in the State of Illinois for two (2) years.

Suspension effective April 9, 2019.

Respondent Adam J. Wiensch shall reimburse the Client Protection Program Trust Fund for any Client Protection payments arising from his conduct prior to the termination of the period of suspension.

Petition by the Administrator of the Attorney Registration and Disciplinary Commission to impose reciprocal discipline pursuant to Supreme Court Rule 763. Allowed. Respondent Ruth A. Batey, who has been disciplined in the State of Indiana, is suspended from the practice of law in the State of Illinois until she is reinstated to the practice of law in the State of Indiana.

M.R.029662 - In re: Steven Edward Dyer. Disciplinary Commission.

Petition by the Administrator of the Attorney Registration and Disciplinary Commission to impose reciprocal discipline pursuant to Supreme Court Rule 763. Allowed. Respondent Steven Edward Dyer, who has been disciplined in the State of Missouri, is disbarred in the State of Illinois.

M.R.029674 - In re: Arnell Damani Harris. Disciplinary Commission.

Motion by the Administrator of the Attorney Registration and Disciplinary Commission to approve and confirm the report and recommendation of the Hearing Board. Allowed. Respondent Arnell Damani Harris is suspended from the practice of law for six (6) months and until further order of the Court.

M.R.029675 - In re: Parker Frank McMahan, Jr. Disciplinary Commission.

Petition by the Administrator of the Attorney Registration and Disciplinary Commission to impose discipline on consent pursuant to Supreme Court Rule 762(b). Allowed. Respondent Parker Frank McMahan, Jr. is suspended from the practice of law for eighteen (18) months.

Suspension effective April 9, 2019.

Respondent Parker Frank McMahan, Jr. shall reimburse the Client Protection Program Trust Fund for any Client Protection payments arising from his conduct prior to the termination of the period of suspension.

M.R.029676 - In re: John Gregory Hoeschler. Disciplinary Commission.

Petition by the Administrator of the Attorney Registration and Disciplinary Commission to impose reciprocal discipline pursuant to Supreme Court Rule 763. Allowed. Respondent John Gregory Hoeschler, who has been disciplined in the State of Minnesota, is reprimanded in the State of Illinois.

Order entered by the Court.

M.R.029677 - In re: Michael Glenn Holzman. Disciplinary Commission.

Petitions by the Administrator of the Attorney Registration and Disciplinary Commission and respondent Michael Glenn Holzman for leave to file exceptions to the report and recommendation of the Review Board. Allowed. Respondent Michael Glenn Holzman is suspended from the practice of law for one (1) year and until he pays restitution in the amount of \$6,115 to Datreon Adams and successfully completes the Attorney Registration and Disciplinary Commission Professionalism Seminar.

Suspension effective April 9, 2019.

Respondent Michael Glenn Holzman shall reimburse the Client Protection Program Trust Fund for any Client Protection payments arising from his conduct prior to the termination of the period of suspension.

M.R.029685 - In re: William Lloyd Meyers. Disciplinary Commission.

Petition by the Administrator of the Attorney Registration and Disciplinary Commission to impose discipline on consent pursuant to Supreme Court Rule 762(b). Allowed. Respondent William Lloyd Meyers is suspended from the practice of law for two (2) years and until further order of Court.

M.R.029686 - In re: Michael Thomas Herbst. Disciplinary Commission.

Petition by the Administrator of the Attorney Registration and Disciplinary Commission to impose discipline on consent pursuant to Supreme Court Rule 762(b). Allowed. Respondent Michael Thomas Herbst is suspended from the practice of law for two (2) years and until further order of the Court, with the suspension stayed after six (6) months by a two (2) year period of probation, subject to the following conditions which shall commence upon the effective date of the Court's order:

- a. Respondent shall abstain from the usage of any and all alcohol, illegal drugs, and non-prescribed controlled substances;
- b. Respondent shall attend meetings as scheduled by the Commission probation officer, via telephone, Skype, or other remote means of communication; and shall submit quarterly written reports to the Commission probation officer concerning the nature and extent of his compliance with the conditions of probation;
- c. Respondent shall, upon request by the Administrator, submit to random substance testing by a mental health professional or facility approved by the Administrator, within eight (8) hours of receiving notice by the Administrator that he shall submit to the testing. The results of the tests shall be reported to the Administrator. Respondent shall pay any and all costs of such testing;

- d. Respondent shall report any alcohol use to the Administrator within seventy-two (72) hours of that usage;
- e. Respondent shall notify the Administrator within fourteen (14) days of any change of address, any change in relapse prevention program, or any change in treating psychiatrist;
- f. Respondent shall continue to receive treatment from Dr. Thomas Herbst, or any other psychiatrist approved by the Administrator. The frequency and duration of treatment, as well as the usage and dosage of any medication prescribed by Dr. Herbst during that treatment, shall be determined by Dr. Herbst;
- g. Respondent shall continue his course of treatment with Matthew D. Rosenberg, M.S.W., C.S.W. The frequency and duration of treatment shall be determined by Mr. Rosenberg and respondent;
- h. Respondent shall provide his psychiatrist, Mr. Rosenberg, and any other treating professional from whom he receives mental health treatment with appropriate releases authorizing those treating professionals to: (1) disclose to the Administrator on at least a quarterly basis information pertinent to the nature of respondent's compliance with any treatment plan; (2) promptly report to the Administrator respondent's failure to comply with the plan; and (3) respond to any inquiries by the Administrator regarding respondent's mental or emotional state or compliance with the treatment plan;
- i. Respondent shall participate in the AA Serenity program offered by Affirmations, 290 W. Nine Mile Road, Ferndale, MI 48220, by attending at least one meeting, or 1.25 total hours, per week. Respondent shall maintain a log of his attendance at the meetings and submit them to the Administrator with his quarterly reports;

- j. Respondent shall participate in the Men's Discussion Group program offered by Affirmations, 290 W. Nine Mile Road, Ferndale, MI 48220, by attending two meetings per month, or 4 total hours, per month. Respondent shall maintain a log of his attendance at the meetings and submit them to the Administrator with his quarterly reports;
- k. Respondent shall comply with the Illinois Rules of Professional Conduct and shall timely cooperate with the Administrator in providing information regarding any investigations relating to his conduct;
- l. Respondent shall reimburse the Commission for costs of this proceeding as defined in Supreme Court Rule 773 and shall reimburse the Commission for any further costs incurred during the period of probation;
- m. Probation shall be revoked if respondent is found to have violated any of the terms of probation. The remaining eighteen (18) months of the two (2) year suspension shall commence from the date of the determination that any term of probation has been violated and shall continue until further order of the Court; and
- n. Probation shall terminate without further order of the Court provided that respondent complies with the above conditions.

Respondent Michael Thomas Herbst shall reimburse the Client Protection Program Trust Fund for any Client Protection payments arising from his conduct prior to the termination of the period of suspension/probation.
