M.R.029708 - In re: Doug Allen Bernacchi. Disciplinary Commission.

Motion by respondent, Doug Allen Bernacchi for a hearing on the Administrator's petition for reciprocal discipline pursuant to Supreme Court Rule 763. Denied.

Petition by the Administrator of the Attorney Registration and Disciplinary Commission to impose reciprocal discipline pursuant to Supreme Court Rule 763. Allowed. Respondent Doug Allen Bernacchi, who has been disciplined in the State of Indiana, is suspended from the practice of law in the State of Illinois for one (1) year and until further order of the Court.

Respondent Barry Michael Lewis is suspended from the practice of law for five (5) months, as recommended by the Review Board.

Suspension effective June 11, 2019.

Respondent Barry Michael Lewis shall reimburse the Client Protection Program Trust Fund for any Client Protection payments arising from his conduct prior to the termination of the period of suspension.

Petitions by the Administrator of the Attorney Registration and Disciplinary Commission and respondent Adam Samuel Tracy for leave to file exceptions to the report and recommendation of the Review Board. Allowed. Respondent Adam Samuel Tracy is suspended from the practice of law for one (1) year.

Suspension effective June 11, 2019.

Respondent Adam Samuel Tracy shall reimburse the Client Protection Program Trust Fund for any Client Protection payments arising from his conduct prior to the termination of the period of suspension.

Petition by the Administrator of the Attorney Registration and Disciplinary Commission to impose discipline on consent pursuant to Supreme Court Rule 762(b). Allowed. Respondent Stephen John Dine is suspended from the practice of law for thirty (30) days.

Suspension effective June 11, 2019.

Respondent Stephen John Dine shall reimburse the Client Protection Program Trust Fund for any Client Protection payments arising from his conduct prior to the termination of the period of suspension.

Motion by the Administrator of the Attorney Registration and Disciplinary Commission to approve and confirm the report and recommendation of the Hearing Board. Allowed. Respondent Theodore Arthur Woerthwein is disbarred.

M.R.029779 - In re: Jeffrey Wade Deer. Disciplinary Commission.

Motion by Jeffrey Wade Deer to strike his name from the roll of attorneys licensed to practice law in Illinois pursuant to Supreme Court Rule 762(a). Allowed. Effective immediately.

M.R.029780 - In re: Paul Dee Boudreau. Disciplinary Commission.

Petition by the Administrator of the Attorney Registration and Disciplinary Commission to impose discipline on consent pursuant to Supreme Court Rule 762(b). Allowed. Respondent Paul Dee Boudreau is suspended from the practice of law for ninety (90) days and until he pays the ARDC \$6,199 in past-due registration and late fees for the period from 2009 through 2018.

Petition by the Administrator of the Attorney Registration and Disciplinary Commission to impose reciprocal discipline pursuant to Supreme Court Rule 763. Allowed. Respondent Gregory P. Allen, who has been disciplined in the State of California, is disbarred in the State of Illinois.

M.R.029815 - In re: Cheryl Ann Powell. Disciplinary Commission.

Petition by the Administrator of the Attorney Registration and Disciplinary Commission to impose discipline on consent pursuant to Supreme Court Rule 762(b). Allowed. Respondent Cheryl Ann Powell is suspended from the practice of law for one (1) year and until further order of Court, with the suspension stayed after sixty (60) days by a two (2) year period of probation subject to the following conditions which shall commence upon the effective date of the Court's order:

- a. Respondent shall comply with any and all treatment, medication and continuing care recommendations of Dr. Miriam Schroeder, or another psychiatrist and treatment program approved by the Administrator;
- b. Respondent shall provide the Administrator and Dr. Schroeder with an appropriate release, authorizing the treating professionals to: (1) disclose to the Administrator information pertaining to the nature of respondent's compliance with any treatment plan established with respect to respondent's condition; (2) to promptly report to the Administrator respondent's failure to comply with any part of an established treatment plan; and (3) to respond to any inquiries by the Administrator regarding respondent's treatment and compliance with any established treatment plan;
- c. Respondent shall attend meetings as scheduled by the Commission probation officer. Respondent shall submit quarterly written reports to the Commission probation officer concerning the status of her practice of law and the nature and extent of her compliance with the conditions of probation;

- d. Respondent shall comply with the provisions of Article VII of the Illinois Supreme Court Rules on Admission and Discipline of Attorneys and the Illinois Rules of Professional Conduct and shall timely cooperate with the Administrator in providing information regarding any investigations relating to her conduct;
- e. Respondent shall reimburse the Commission for the costs of this proceeding as defined in Supreme Court Rule 773 and shall reimburse the Commission for any further costs incurred during the period of probation;
- f. At least thirty (30) days prior to the termination of the period of probation, respondent shall reimburse the Client Protection Program Trust Fund for any Client Protection payments arising from her conduct;
- g. Respondent shall notify the Administrator within seven (7) days of any arrest or charge alleging her violation of any criminal or quasi-criminal statute or ordinance;
- h. Respondent shall notify the Administrator within fourteen (14) days of any change of address; and
- i. Probation shall be revoked if respondent is found to have violated any of the terms of probation. The remaining portion of the one (1) year period of suspension shall commence from the date of the determination that any term of probation has been violated and shall continue until further order of the Court.

Petition by the Administrator of the Attorney Registration and Disciplinary Commission to impose reciprocal discipline pursuant to Supreme Court Rule 763. Allowed. Respondent Christopher Lauren Graham, who has been disciplined in the State of Texas, is disbarred in the State of Illinois.

M.R.029837 - In re: Matthew Ryan Booker. Disciplinary Commission.

Petition by the Administrator of the Attorney Registration and Disciplinary Commission to impose discipline on consent pursuant to Supreme Court Rule 762(b). Allowed. Respondent Matthew Ryan Booker is suspended from the practice of law for three (3) years and until further order of Court, with the suspension stayed after eighteen (18) months by a two (2) year period of probation, subject to the following conditions which shall commence upon the effective date of the Court's order:

- a. Respondent shall engage in regular and continuous treatment with a psychiatrist approved by the Administrator and he shall comply with any and all treatment, medication and continuing care recommendations by the psychiatrist;
- b. Respondent shall provide the Administrator and his treating psychiatrist with an appropriate release, authorizing the treating professionals to: (1) disclose to the Administrator information pertaining to the nature of respondent's compliance with any treatment plan established with respect to respondent's condition; (2) to promptly report to the Administrator respondent's failure to comply with any part of an established treatment plan; and (3) to respond to any inquiries by the Administrator regarding respondent's treatment and compliance with any established treatment plan;
- c. Respondent shall attend meetings as scheduled by the Commission probation officer. Respondent shall submit quarterly written reports to the Commission probation officer concerning the status of his practice of law and the nature and extent of his compliance with the conditions of probation;
- d. Respondent shall comply with the provisions of Article VII of the Illinois Supreme Court Rules on Admission and Discipline of Attorneys and the Illinois Rules of Professional Conduct and shall timely cooperate with the Administrator in providing information regarding any investigations relating to his conduct;
- e. Respondent shall reimburse the Commission for the costs of this proceeding as defined in Supreme Court Rule 773 and shall reimburse the Commission for any further costs incurred during the period of probation;

- f. At least thirty (30) days prior to the termination of the period of probation, respondent shall reimburse the Client Protection Program Trust Fund for any Client Protection payments arising from his conduct;
- g. Respondent shall notify the Administrator within fourteen (14) days of any change of address; and
- h. Probation shall be revoked if respondent is found to have violated any of the terms of probation. The remaining portion of the three (3) year period of suspension shall commence from the date of the determination that any term of probation has been violated and shall continue until further order of the Court.
